Karenni State Human Rights Violation Situation

1st to 30th April 2022

The situation in Karenni State is deteriorating every single day. We absolutely need international community and UN agencies assistance and attention for Karenni IDP and civilian. In the month alone of April 2022:

At least (10) civilian killed by SAC within April 2022. Up to 128 houses and building were intentionally set on fire, shelled and destroyed. At least 15 civilian arrested and detained. Up to (6) times of landmine and mine related item explosion and caused three civilian injured. Up to 26 times of civilian targeted motor shell.

Two women were killed by SAC's motor shell in Pa Dar Nyeh village in Loikaw Township. Three civilian were fired and killed during traveling by motorbike in Daw Nyeh Khu village areas, Hprusoe Township and (8) year old boy was open fired and killed at Chit Kae village, Loikaw Township. Two dead body of missing civilian recovering in Zee Hpue Kong, Deemaw Soe township. One old woman was found dead in her home at Ngu Palaw village, Deemaw Soe township. At least (7) civilian injured by motor shelling.

Up to 128 houses/building burned down and damaged within this April 2022. Up to 105 house/building intentionally burned down by SAC troops mainly in Ngwe Taung Ywe Tit village, Hprusoe Township, Tay Hsoe Leh village and Paung Taw village, Deemaw Soe Township and some building in Loikaw Township. At least 23 building damaged by motor shelling while including three religion building in both Deemaw Soe and Hprusoe Township.

One of the highlight in this April was Landmine issue. At least 5 times of landmine explosion after the SAC troop withdraw from village. Four times happen in Htee Poe Soe village areas and one time in Loi Tamu village, Loikaw Township. Two times was step by motorbike and three times was step by "Tawlagyi" and one mini-injured. Two children were mini-injured by un-identify mine or ammunition explosion in Daw Oo Khu ward, Loikaw, Loikaw township.

Up to 2,500 new IDP within this April and at least 200,000 Karenni people fled their home as IDP. Most of IDPs stay in IDP temporary camp and shelter. The IDP are not only in-need of basic Food, shelter, medical care and education... Now the risk of different type of violation, social-sociology impact and human trafficking as well.
